

## Why Dogs Don't Live Longer Than People.....

Being a veterinarian, I had been called to examine a tenyear- old Irish Wolfhound named Belker. The dog's owners, Ron, his wife, Lisa, and their little boy, Shane, were all very attached to Belker and they were hoping for a miracle.

I examined Belker and found he was dying of cancer. I told the family there were no miracles left for Belker, and offered to perform the euthanasia procedure for the old dog in their home.

As we made arrangements, Ron and Lisa told me they thought it would be good for the four-year-old Shane to observe the procedure. They felt as though Shane might learn something from the experience.

The next day, I felt the familiar catch in my throat as Belker's family surrounded him. Shane seemed so calm, petting the old dog for the last time, that I wondered if he understood what was going on. Within a few minutes, Belker slipped peacefully away. The little boy seemed to accept Belker's transition without any difficulty or confusion.

We sat together for a while after Belker's death, wondering aloud about the sad fact that animal lives are shorter than human lives. Shane, who had been listening quietly, piped up, "I know why."

Startled, we all turned to him. What came out of his mouth next stunned me. I'd never heard a more comforting explanation.

## **Election Time ....at GPAC**

Hi everyone. It is that time again. Not only is there a Federal Election but GPAC is getting in on the election hoopla and having one of our own. If you have adopted in the last year or so, you may or may not know that GPAC is a registered Charity and as such, we have a Board of Directors who are elected every two years at the Annual General Meeting. It is still to be completely confirmed but the tentative date and location of this years' Annual General Meeting will be at the Pampered Paws Inn in Hammonds Plains on the 4th of March, 2006. A luncheon will be served and we will review the previous year as well as plans for this year. Also a new board will be elected for the next 2 years.

Each election all the members of the current board as well as anyone wishing to fill a board position will be nominated in the weeks before the meeting and at the meeting a vote will confirm the position. In past years as well as this year, nominations will be accepted via mail or email for the board positions. What we need is a letter of intent to let us know that you are interested in joining the board of directors. This should state which position you would like to be nominated for and a little bit of your background info that shows what type of qualifications you may have that will help the members decide who is the best person to take on that particular position. The letter of intent should be sent to Election C/O GPAC, PO Box 38203, Dartmouth, NS B3B 1X2. Please have these letters in the box by Feb 10th, 2006.

After the nominations are received, a file will be posted with the nominations so the members will have the information required to make an informed decision. Voting by proxy will be allowed for people who are out of town or who can not make it to the AGM but still want to vote. The proxy form to vote will be posted on the website and the discussion group as soon as we receive all the nominations. The proxies can be mailed to the post office box or emailed to a current board member. The proxies will remain sealed until the day of the election at which time they will be added in with the votes tallied at the AGM. If you have any questions or concerns regarding the above procedures feel free to contact me at fastdog1@ns.sympatico.ca or call me at 902-435-1099. This election applies to all provinces but note that Newfoundland has a board as well that is elected in by Newfoundland members. They can still vote for the Society's Board of Directors. The Board members are listed as such on the NS Registry of Joint Stocks.

The responsibilities of each of the Board Positions are as follows. Please read them carefully and if it seems like a commitment you are able to make, please forward your letter of intent as soon as possible. This election is not a popularity contest in any way. There is no campaigning or any manner of competition. There is a lot of responsibility and time put into each position and it is not to be taken lightly. Again... if you have any questions or concerns please feel free to contact a current board member.

- Submit a budget proposal for position operating expenses

## **Director Of Operations**

#### Responsible for:

- Signing authority for commitments and financial obligations as required by the Society as approved by the Board
- Coordinating, booking, following up, screening and final approval of adoption applicants
- Providing information to Board regarding availability of dogs for adoption, adoption applicants, new foster homes and status of dogs in foster homes
- Advising Board of anticipated expenses for Operations
- Providing financial information and receipts regarding Operations and retail sales to Board Treasurer on a monthly basis
- Acting as spokesperson on behalf of GPAC
- Submit a budget proposal for position operating expenses

#### **Secretary - Board of Directors**

#### Responsible for

- Recording all the meetings
- Accurate and timely distribution of "Meeting Minutes" and other information to the Board and GPAC Members
- Acting as custodian for, and exercising due diligence in safeguarding, all business records, statements, seals, papers and any other materials entrusted into their care, and delivering all such items as and when requested by the Board or when authorized by a resolution of the Board
- Signing By-laws
- Supplying Register of Joint Stock Companies with minutes, special meeting minutes and / or all updates of Bilaws on a regular basis or as deemed necessary under the Society's guidelines
- Performing other duties as directed by the Board

### **Treasurer - Board of Directors**

### Responsible for:

- Exercising due diligence in following GPAC audit controls as deemed necessary by the Board and Revenue Canada
- Directing the financial resources budgeting process
- Submit a budget proposal for position operating expenses
- Maintain Books Through the use of Quickbooks Charity version
- Accounts Payable & Receivable and Expense Reimbursement

#### **Fundraising Committee Chair - Board of Directors**
